Improvements and Fixes

Collaboration & Communication

Mobile - Main navigation now displays when there is only one option

Updated the main navigation to display even when there is only one menu item, providing a visual guide to indicate the current page.

Library - Document Search - Fix applied to improve consistency when using the keyword and topic filters

An issue was resolved where combinations of the Keyword and Topic filters could produce inconsistent search results

Forms & Checklists

Forms - Two notifications sent when deleting a note

Resolved the issue that occurred when a note was deleted from a form in the main application, 2 notifications were being sent.

Form Library Item - Allow advanced editing features in the Form Library Description

Enabled advanced editing features for the Form Library Item - Description field, including image insertion, text customization, and basic editing functions. These enhancements match the functionality of the Training Catalog.

Forms - Deleting or changing an answer used as a condition on a form can caused an error

Fixed an issue where deleting an answer option—whether defined in the Form Builder or part of a Standard Response Set—could break forms that rely on that answer for conditional logic. The system now blocks deletion of such answers to maintain form stability and prevent loading errors.

Forms > Conditional Questions > Only show displayed questions when reviewing/exporting forms

Improved the display of a completed form, to only show questions that were presented to the user based on the form's branching logic. Previously those questions were shown as "Not Answered", which made analysis and evaluation difficult.

2.0 My Activities -> Completed - is slow for some clients since it executes too many queries to retrieve the types dropdown

Optimized the loading of the "Completed" tab for clients with large datasets. We reduced redundant queries related to the activity type dropdown, resulting in faster load times and a smoother user experience.

Form Builder - Stop from deleting a question used as a Form Library Item Subject

In the Form Builder, questions designated as the *Form Library Item Subject* are now safeguarded from deletion. This ensures that key identifying fields remain intact and prevents accidental removal of critical form metadata.

Forms - Fixed editing issue on published form responses

Resolved a bug where users could appear to edit responses on published forms, even though those changes were not actually saved. This fix ensures that once a form is published, its responses are properly locked and cannot be modified, maintaining the integrity of finalized data.

Form Builder - Prevent deleting a section with questions that are used in conditions

Fixed an issue in the form builder where users could delete questions that were being used as conditions for other questions. This fix ensures that any question serving as a dependency for conditional logic cannot be removed, preserving the integrity of the form's logic.

Forms - Duplicate possibility on Form Submission Document Results

Resolved an issue where simultaneous form submissions could occasionally result in duplicate entries. We've added safeguards to ensure each submission is uniquely recorded, improving data accuracy and system reliability.

Form Submission Manager - Performance Improvements

Optimizations were carried out to further improve the performance of data retrieval for Form Submission Manager.

Form Builder - You can delete a section that is used in conditions

Addressed an issue where users could delete entire sections that included questions used as conditions for other questions. With this fix, any section containing a question that serves as a conditional trigger is protected from deletion, ensuring consistent and reliable form behavior.

2.0 > Conditional Form - Required questions can be hidden or excluded when filling out a form

Fixed an issue where forms with chained conditional questions—especially when one conditional question depended on another—could trigger the error

"CAN'T_COMPLETE_NOT_ALL_CONDITIONS_MET" during response evaluation. This update ensures more reliable handling of complex conditional logic across sections.

Forms - Performance Optimization - Several performance fixes

There were several performance fixes (4) applied to forms, especially in the areas of saving and reviewing forms in the library and my activities.

Admin - Career Postings - Job Types should be using Consumer permissions

Updated the Career Postings form to change the required permissions from "Who can edit this Job Type" to "Who can use this Job Type" when adding a new 'Type' on the Categories & Types tab.

My Activities - Fixed intermittent blank screen when viewing the page

In My Activities, when scrolling down the list, after displaying a number of records, the next page of records were retrieved. An issue where loading the next page of data could result in a blank page and error if the data returned incorrectly ordered.

Sessions - Remove requirement for entry in Building field to display Additional Information in Enrollment Banner

Fixed an issue where entering information in the Building field was required to display the Additional Information banner on the session information page.
